Dog walking on Port Meadow and Wolvercote Common carries responsibilities

Just recently there have been a couple of incidents of uncontrolled dogs chasing horses. This has culminated a foal being seriously injured, which required treatment by a vet. Whilst most people know it is an offence for a dog owner not to clean up if their dog fouls on public land such as the Meadow (it can carry an £80 fixed penalty or even incur a fine of up to £1,000), many may not realise there are also other responsibilities when walking dogs.

Dogs should under 'control'. However, there seems to be a misunderstanding about the interpretation of 'control'. Whilst people quite rightly let their dogs off their leads this should only be the case if the dog is under 'control'. This means not harassing other walkers (not everyone likes dogs jumping up at them) and, more importantly, not chasing and possibly injuring animals on the Meadow. The Meadow and Common are common land with grazing rights which date back many hundreds of years and consequently Oxford Council publishes guide-lines on its use. There are specific details about grazing rights and also about dogs and dog walkers in public places such as the Meadow. One of the rules covers the maximum number of dogs a single person can walk at one time, which is 4 dogs. Recently there has been an increase in the number of professional dog walkers on the Meadow, many of whom seem to have more than 4 dogs which are also often seen running loose. Livestock on the Meadow can often be spooked and there is always the danger of stampedes, which could be caused by uncontrolled dogs and in recent years by the increase in the use of drones (it should be noted that drones are not permitted on the Meadow or Common for this very reason).
